



INTRODUCTION

As part of the monitoring and evaluation mechanism established to monitor the quarterly implementation of the activities and sub activities of the work plan 2018, this report highlights the implementation status of activities and sub activities set forth in the fourth quarter of 2018. 



The chart below shows the number of activities and sub-activities assigned to section/unit(s). Details of status of the sub-activities of each section/unit are given under activities completed per section/unit.




Administration & Support Service Section





Human Resources Section








Legal & Investigation Division








Monitoring & Evaluation Section








Policy Planning & International Relations Section








Project Management Section








Training & Advocacy Section
