





Introduction

As part of the monitoring and evaluation mechanism established to monitor the quarterly implementation of the activities and sub activities of the work plan 2020, this report highlights the implementation status of activities and sub activities set forth in the first quarter of 2020. The duration of quarter two is from 1st January to 31st March 2020. During this quarter, a total of 68 activities and 146 sub-activities were to be carried out to achieve 37 strategic activities and 11 outcomes. Out of the total sub-activities to be completed in the fourth quarter, 66 sub-activities were completed. As Government offices were closed from 19th March 2020 onwards due to COVID-19, some of the activities that were to be completed by the end of first quarter were put on hold, and thus not completed. The chart presented below shows status of completion of sub-activities carried out by LGA during the quarter.





Number of activities and sub-activities assigned to each section/unit





Status of completion of sub-activities assigned to each section/unit
