



Introduction

As part of the monitoring and evaluation mechanism established to monitor the quarterly implementation of the activities and sub activities of the work plan 2019, this report highlights the implementation status of activities and sub activities set forth in the fourth quarter of 2019. The duration of quarter two is from 1st October to 31st December 2019. During this quarter, total of 51 activities and 125 sub-activities were to be carried out to achieve 12 outcomes. Out of the total sub-activities to be completed in the fourth quarter, 82 sub-activities were completed. 



The chart below shows the number of activities and sub-activities assigned to section/unit(s). Details of status of the sub-activities of each section/unit are given under activities completed per section/unit.







Status of completion of sub-activities assigned to each section/unit



Administration & Support Service Section






Council Corporate Services Section



Human Resources Section








Legal & Investigation Division








Monitoring & Evaluation Section




Policy Planning & International Relations Section


Council Digitalization and Projects Section
